Providing care at more than 110 locations across five counties, our team is driven by a shared mission to deliver high-quality healthcare that is accessible to all.



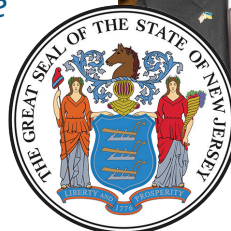
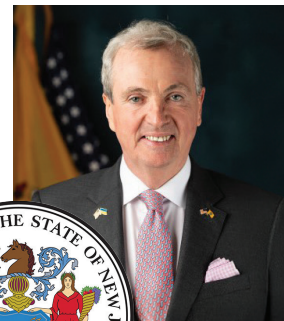

Improved Nutrition Fueled by Our **Community Mobile Market and Community Pantries**

Atlantic City currently ranks as New Jersey's second largest food desert, a stark reality that impacts the overall health and well-being of the city's most vulnerable residents. This is unacceptable, and we're taking major strides to tackle food and nutrition insecurity in Atlantic City and the surrounding area, joining with community partners to bring fresh produce and wholesome pantry staples to our residents.

In June, AtlantiCare launched our Community Mobile Market – a grocery store on wheels, to deliver healthy, fresh and affordable foods, priced below average market rates. Making regular stops in designated areas throughout Atlantic City, the Community Mobile Market offers pantry items and a steady rotation of fresh fruits and vegetables. Our Community Mobile Market is made possible through a generous sponsorship from the New Jersey Economic Development Authority (NJEDA) and the support of donors including the Gormley and Levine Family Foundations.

AtlantiCare also operates two healthful food pantries in Hammonton and Atlantic City that, over the past year, have served more than 17,000 area residents. The pantries provide residents dignity by allowing them to choose the foods they prefer to feed their families. We provide a variety of healthy choices including low-prep food options for those with limited cooking equipment, cooking classes and meal packs with healthy recipes to demonstrate the ease of maintaining a healthy diet.

First Dental Care Practice Opens in Atlantic City

AtlantiCare takes a holistic view of healthcare, recognizing that oral health is integral to our patients' overall well-being.

Poor oral health has been linked to a range of chronic conditions, including heart disease, diabetes and respiratory infections. By addressing oral health issues early on and proactively, we aim not only to enhance our patients' quality of life but also to reduce the need for avoidable emergency department visits.

In January 2024, we held the grand opening of our first dental practice as part of our Federally Qualified Health Center (FQHC) program at AtlantiCare's Medical Arts Pavilion in Atlantic City. Treating over 1,500 area residents since opening, the practice houses nine dental care suites and an on-site lab, in a state-of-the-art 4,200 sq. ft. facility.

Safe Beginnings Program

A healthy life should begin with a strong start. AtlantiCare's Safe Beginnings program ensures this and is making a meaningful impact on reducing infant and maternal mortality and morbidity rates in Atlantic City. Recognizing the challenges many pregnant patients face in accessing care, Safe Beginnings breaks down barriers for at-risk mothers and those with high-risk pregnancies, providing safe, comprehensive care and support. The program offers prenatal, postnatal and postpartum care to support women, children and families in Atlantic City – regardless of their ability to pay. This includes connecting patient families to resources for nutrition, housing, employment and transportation to medical appointments.

Thanks to generous donations, including a \$1.3 million multi-year grant from the Casino Reinvestment Development Authority, the Safe Beginnings team, which includes certified nurse midwives, social workers, neonatologists, peer specialists, certified doulas and registered nurses, has served over 400 women and their families since its launch in 2021, including 200 families in 2024. This year, \$20,000 worth of baby safety items were provided to families in need.

By supporting each mother and baby with compassion and care, we're setting up children and families for brighter and healthier futures.



Children's Health Programs

In addition to our Pediatric services at the Medical Arts Pavilion, AtlantiCare partners with area schools to provide physicals, behavioral health services and vaccine clinics to our vulnerable pediatric populations. In 2024, AtlantiCare provided over \$71,000 in the form of mini-grants to local schools to ensure that health remains a lifelong priority for our community.

Delivering Primary & LGBTQ+ Care

AtlantiCare proudly opened the region's first primary and specialized care practice dedicated to serving the LGBTQ+ community. Located in Atlantic City, the mission of the Primary & LGBTQ+ Care Center is to provide culturally competent, identity-affirming and judgement-free care in an environment where patients feel safe and respected. In our first full year of operation, the practice has provided gender and identify-affirming hormonal treatment; pre-op screening/documentation support; sexual health and sexually transmitted infections education, screenings and treatment; HIV management; preventative care and more to nearly 1,000 patients.

An essential component of our digital transformation is the launch of a comprehensive Command Center, which provides our team with a broader, more transparent view of operations across the entire healthcare system. This enables us to support patients and our providers through their entire care journey, making the experience frictionless and seamless.

More importantly, it allows us to intervene in real time – whether patients are inside or outside of the four walls of our healthcare facilities, enabling us to be more proactive with patient care. For example, alerting us to critical changes in a diabetic patient's status through their glucose monitoring device. This early intervention, monitored and initiated outside our facility, enables us to respond quickly and often prevent more serious health issues from developing.

AtlantiCare Named First Innovation Partner for Oracle's Clinical AI Agent

The Clinical AI Agent combines comprehensive clinical intelligence with a multimodal voice user interface to automate and unify a wide range of clinical workflows that are activated during patient-provider interactions. The technology captures key details needed to populate the patient's electronic medical record (EMR) without requiring the provider to manually input patient information. It is smart enough to filter out unrelated conversations, such as talk about last night's football game. Early results have been very promising, with AtlantiCare doctors reporting better patient engagement and greater professional satisfaction, thanks to the significant reduction in manual documentation during a patient visit.

By leveraging the Clinical AI Agent, we aim to improve each patient's visit by allowing our providers to focus on what's most important – the patient.

Using AI to Stop Lung Cancer from the Start

When it comes to lung cancer, early detection is the key to saving lives. Thanks to groundbreaking advances in artificial intelligence, AtlantiCare is empowering patients with access to tools that can help clinicians identify and address lung cancer in its earliest, most treatable stages.

AtlantiCare is proud to be the first healthcare system in the Northeast to utilize the Optellum® Virtual Clinic, the world's first AI-powered clinical tool designed for earlier lung cancer diagnosis and decision support.

This technology enhances AtlantiCare's Interventional Pulmonology team, led by Dr. Amit Borah at the Lung Nodule Clinic, to identify and

Isaiah Rivera's Journey

Compassionate Care That Cures

Isaiah Rivera is a hardworking man in his early thirties who married his high school sweetheart, Ashley. Together, they are raising three children under the age of six. Isaiah had never smoked a cigarette or used tobacco products in his life. However, in June 2024, his life took an unforeseen turn when he was diagnosed with Stage II Squamous Cell Carcinoma on his tongue – a common form of cancer that affects not just the skin but also mucous membranes like those in the mouth.

Under the expert care of Dr. James Wurzer, one of the region's leading radiation oncologists at the AtlantiCare Cancer Care Institute, Isaiah and his family started their cancer care journey.

"My family is my world – I wanted to be treated close to home, and I already knew about AtlantiCare's reputation," Isaiah shared. "Being able to drive 25 minutes for expert care and treatment every day made all the difference for me and my family."

A cancer diagnosis can take an emotional, physical and mental toll, leaving patients unsure about next steps. Having a strong support system within your healthcare team can make a significant difference – especially when advanced, high-level care is needed. AtlantiCare's dedicated nurse navigators and certified oncology nurses provide that personalized support every step of the way. The nurse navigators and care team played a key role in coordinating Isaiah's treatment plan, scheduling his surgeries, chemotherapy and radiation therapy, which he completed in 2024.

Isaiah emphasized the vital role of his medical oncology team, nurse navigator, and support services team, adding, "They would call my wife just to ask how she was doing, how she was holding up. People often focus on the person with cancer and forget about the support system at home."

Today, Isaiah is back at work running his own business and cherishing his second chance at life. "I feel great," he said. "I'm incredibly grateful for the team at AtlantiCare's Cancer Care Institute; from day one, we were made to feel like family."

Together, these tools enable AtlantiCare's lung experts to pinpoint, biopsy and remove suspicious nodules with unmatched accuracy at their earliest stage, neutralizing potential cancers before they can grow or spread.

By harnessing these cutting-edge technologies, AtlantiCare is redefining the standard of care for lung health, offering patients the best chance at a cancer-free future and reinforcing our commitment to innovation and excellence in patient care.

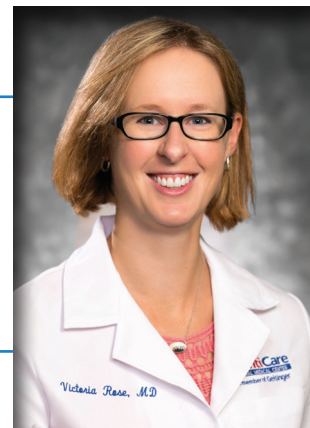

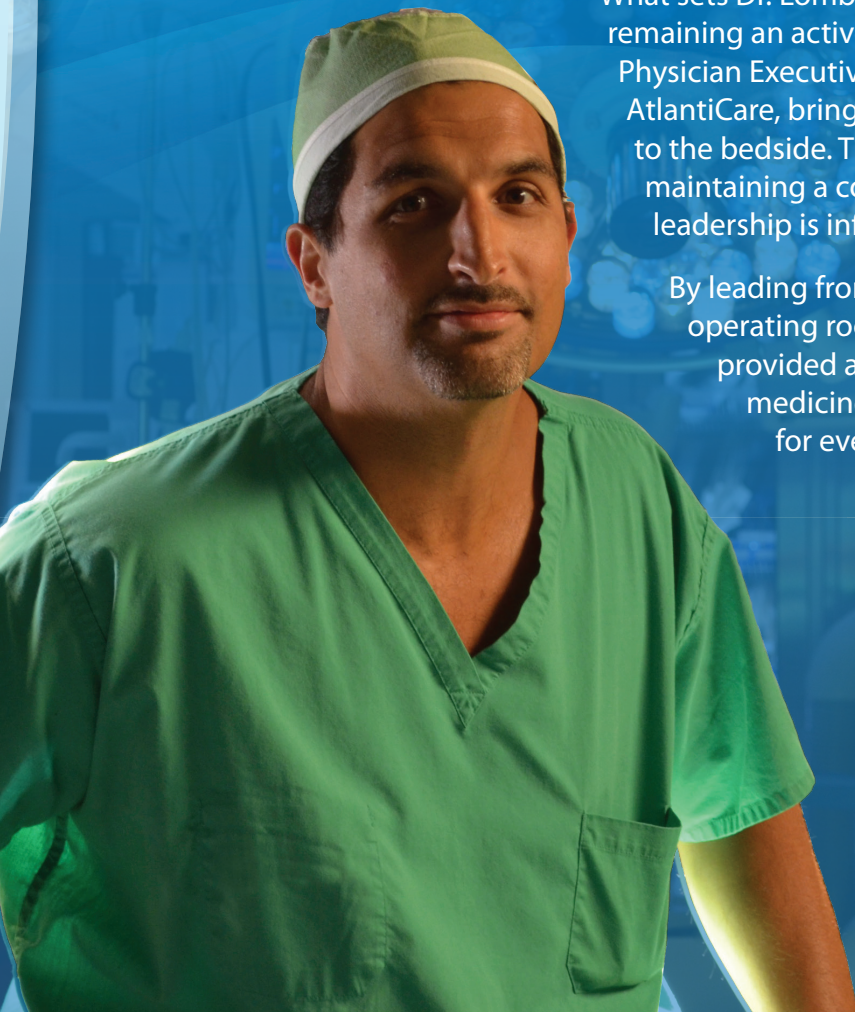

From Tragedy to Triumph Vilte Gruzdyte's Journey of Hope

For Vilte Gruzdyte, a promising 20-year-old Lithuanian student, her summer in the U.S. was meant to be a cultural adventure, but in July, while enjoying a night out with friends, she was struck by a stray bullet, sustaining severe brain injuries that left her clinging to life.

She was airlifted to AtlantiCare Regional Medical Center's Trauma Center in Atlantic City, where a team of specialists was prepared for the challenge ahead. "These cases are rare and critical," explained Erol Veznedaroglu, MD, FACS, FAANS, FAHA ("Dr. Vez"), one of the most experienced cerebrovascular neurosurgeons in the country.

Vilte's situation was grim. The bullet caused extensive and devastating damage, leaving her unresponsive and fighting for her young life. Dr. Vez performed emergency surgery with intricate precision, carefully removing part of her skull to relieve pressure and repair her brain. It was a high-stakes procedure that offered no guarantees and low survival rates for patients with such severe injuries to the brain. "Our Trauma and Neurosurgery team was built to deliver the precision and speed needed to save lives in moments like this," said Dr. Vez.

Within days, signs of hope emerged. Vilte began responding to commands, defying the odds. Nine days after the shooting, she spoke her first words. Within weeks, she was taking her first steps, a testament to her strength and the expertise of AtlantiCare's physicians in neurosurgery and trauma care.

After weeks of intensive care, Vilte transitioned to a rehabilitation center, determined to reclaim her life. Today, her recovery continues at home in Lithuania surrounded by her family and in contact with her AtlantiCare care team.

For patients facing the most critical challenges, Vilte Gruzdyte's survival and remarkable recovery stand as a testament to the exceptional care provided at AtlantiCare.

Our collaboration with GNI's team of specialists enables AtlantiCare to incorporate the latest research insights and treatment strategies, for conditions ranging from Alzheimer's Disease, cognitive disorders, Parkinson's Disease, epilepsy and multiple sclerosis to more urgent or emergent conditions like stroke and TIA (transient ischemic attack).

Through this partnership, our Neuroscience specialists can employ an integrative approach to care, where every patient benefits from the seamless collaboration of a multidisciplinary team of experts in neurosurgery, neurology, psychiatry, internal medicine, pharmacology, physical therapy, speech therapy and more. These specialists work together in real time to assess a patient's condition from every possible angle. Complemented by leading-edge research, GNI clinicians build individualized treatment plans that maximize health outcomes for every patient.

Advanced Care Through Robotic-Assisted Surgery

AtlantiCare's pledge to transform how patient-centered care is delivered includes investments in the latest advancements in robotic-assisted surgical platforms. AtlantiCare's robotic-assisted surgery program is proven to deliver superior patient satisfaction and outcomes demonstrated through the use of less pain medication, faster recovery times and decreased overall cost of care. By equipping our surgeons with state-of-the-art technology in healthcare, we ensure our patients have access to minimally invasive surgical options close to home.

Some of our current suite of robotic-assisted surgical systems include the Intuitive Ion Bronchoscopy system for early-stage lung cancer detection, Aquablation® therapy with the HYDROS™ Robotic System for enlarged prostate and the da Vinci Robotic-Assisted Surgical System, all of which are revolutionizing the field of minimally invasive surgery.

Utilizing cutting-edge robotic-assisted technologies, our team of leading surgeons can perform both simple and complex procedures with enhanced precision, both from a dexterity perspective and 3D crystal-clear visualization of the surgical area than is possible with traditional minimally invasive surgery. The robotic arms, which are guided by the surgeon via console, can maneuver in ways conventional surgical tools cannot, enabling greater control and precision during procedures.

This year we expanded our fleet of da Vinci Robotic-Assisted Surgical Systems to a total of five, making AtlantiCare home to one of the largest fleets in South Jersey. This investment enables AtlantiCare to provide 24/7 access to robotic-assisted surgeries, supporting both emergency and elective procedures.

Our robotic-assisted surgical services extend far beyond the procedure itself, including smaller incisions compared to traditional open or laparoscopic surgery, a lower risk of infection, fewer complications and shorter recovery times. Those undergoing our robotic-assisted surgery typically spend less time in the hospital and return to their normal activities quicker than those who have traditional open surgery. AtlantiCare's robotic-assisted surgery program makes procedures safer, more effective and more accessible to our community.

AtlantiCare is the first healthcare team in Southern New Jersey to offer Aquablation® therapy with the HYDROS™ Robotic-Assisted Surgical System, a game-changer for treating an enlarged prostate, also known as benign prostatic hyperplasia (BPH). This advanced, AI-powered treatment offers real, lasting relief from BPH symptoms while helping men maintain sexual function and bladder control, improving their quality of life.

The HYDROS System leverages insights from over 50,000 procedures, integrating FirstAssist AI™, advanced imaging, and robotic precision to deliver accurate and consistent outcomes. The procedure combines ultrasound imaging and digital cystoscopy (small camera and light) to give surgeons a real-time 3D view of the prostate, enabling a personalized treatment plan tailored to each patient's unique anatomy. Using a heat-free waterjet, the robot precisely removes obstructive tissue while safeguarding critical structures, ensuring efficient and predictable results for prostates of all sizes and shapes.

Behavioral Health

AtlantiCare is making significant strides in addressing substance use disorder and the mental health crisis within our communities, serving as a beacon of hope for those in need. As the largest provider of mental health, addiction recovery and family care social services in southeastern New Jersey, AtlantiCare Behavioral Health offers a comprehensive range of evidence-based recovery services at 17 locations across the region.

Mental Health Urgent Care

AtlantiCare is the only healthcare system in the region offering Mental Health Urgent Care, allowing walk-in patients aged 18+ to receive quick access to mental healthcare right away, without the long wait for an outpatient appointment. Through this life-saving model, our behavioral health specialists also go directly to where a patient is to address their urgent mental health needs, offering psychotherapy, medication management, peer support, case management and seamless connection to ongoing comprehensive care from AtlantiCare. Depending on the patient's needs, this could mean ongoing care at one of AtlantiCare's many service sites including AtlantiCare's Adult Outpatient Services, Virtual Therapy Program or Intensive Outpatient Program.

Since debuting our Mental Health Urgent Care services in 2024, we've seen a significant increase in patients for our Adult Intervention Services. By dramatically lowering barriers to access, AtlantiCare provides a critical lifeline for those in crisis.



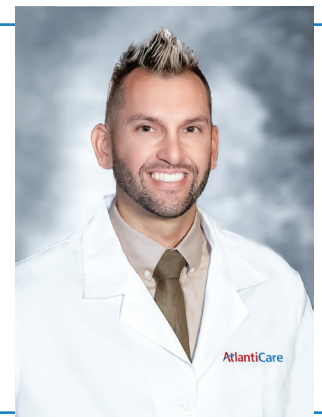
Children's Mobile Response Team

With an increasing demand for behavioral health programs in schools, AtlantiCare is stepping up. We're expanding school-based services by collaborating with school leaders to create a spectrum of mental health support, including on-site screenings, crisis evaluations and additional resources to help students get the care they need.

AtlantiCare Behavioral Health provides 24/7 crisis response services for youth facing mental health and substance use crises. Much like an ambulance, this team arrives on-site to assess the situation, stabilize the patient and connect them to the appropriate care, whether that's behavioral health services or immediate treatment. At a time when access to pediatric mental healthcare is severely lacking nationwide, our Children's Mobile Response Team stands as a model for the nation.

In my experience elsewhere, a huge challenge is that people fall through the cracks when they need to secure care from various providers and health systems. Combating Substance Use Disorder

In May of 2024, the generosity of more than 650 AtlantiCare donors raised over \$645,000 at the AtlantiCare Foundation's 63rd annual Century Club Gala to support behavioral health and addiction services.

Through philanthropic support and local funding, AtlantiCare Behavioral Health is advancing critical initiatives by offering peer support specialists, transportation assistance and easier access to necessary treatments without barriers.

AtlantiCare Behavioral Health Bridge Clinic, which launched in 2022, provides immediate access to detox and recovery services for those in acute addiction crises, playing a vital role in combating the opioid crisis in our region, and bridging the gap until longer-term care becomes available. In early 2024, we expanded the clinic to offer access seven days a week, ensuring that more patients receive timely support.

In less than two years, the Bridge Clinic has increased its transition in care rate from 6% to an incredible 96%, providing critical support to over 1,000 area residents in need.

Doug Martin Shares Wisdom and Hope as a **Peer Recovery Specialist**

Throughout a long battle with addiction, Doug Martin often asked God for guidance on what he should do with his life. What he never expected on his recovery journey was to find his purpose inspiring others to turn their lives around.

After repeated treatment attempts, Doug was ultimately able to gain long-term recovery through the care he received at AtlantiCare's John Brooks Recovery Center (JBRC) in Atlantic City. Doug is now a Certified Peer Recovery Specialist at AtlantiCare Behavioral Health, offering support to individuals who are struggling as he once did. Although Doug's official time in recovery is 10 years, he says, "I believe true recovery time is 24-hours, one day at a time."

AtlantiCare's Peer Recovery Specialists are available to support patients in both in-patient and out-patient settings, offering a meaningful, relatable perspective and a lifeline of connection at every turn along the road to recovery.

Becoming a Peer Recovery Specialist in 2018, Doug could see his impact right away. He recalls a moment from his first assignment at JBRC, the very facility where he finally broke free from addiction, when he sat with a patient one night, hearing the young man's story, recognizing the similarities with his own and offering sympathy and advice. He never expected the card that later came from the patient's parents thanking him for making a difference in their son's life.

Fast forward to today, Doug remains committed to helping others find recovery and hope.

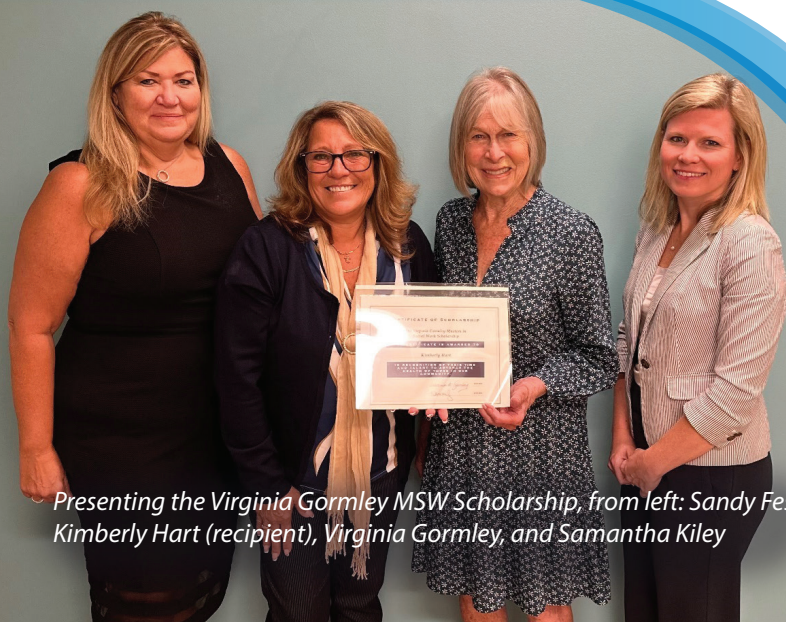
